H&T Member Profile

James Malcolm Monteith

Born on April, 20, 1954 in Birmingham, Alabama. Called Jim since the 4th grade he grew up in the hills of West Birmingham. His father was interested in history, genealogy, and Scottish culture. He grew up with two sisters and one older brother. The family vacationed every summer camping out or staying with relatives all over the Eastern and Southern USA. Attended the Highland Games at Grandfather Mountain in North Carolina in the 60's. Jim played baseball and football in the YMCA program in elementary school. In high school he was on the wrestling team. Jim got a motorcycle at age 17 after begging for three years to his parents.

Attended Auburn University for two years from 1972 to 1974. Transferred to Univ. of Alabama in Birmingham and received a B. S. in Geology there in 1979. Hobbies in his 20's and early 30's were sport skydiving and hang gliding. Despite his mother's fears of his hobbies

she handmade him a custom jumpsuit. His father had him sign a life insurance policy just in case he had a bad day at the drop zone or mountain.

Moved to Houston the day he got his diploma where he entered into the oil business as a seismic geophysicist. Lived in Bakersfield, California for one year in 1981 where he continued his flying hobby by training for his private pilot's license. Returned to Houston in 1982 still in the oil business where he weathered the down turn until 1985 when he was laid off. Unemployed for nearly a year he attended an aircraft mechanics school. In December 1986 he was hired by the Dallas Police Department where he began his career in law enforcement as a patrol officer in NW Dallas in April, 1987. In September 1989 Jim was hired by the Texas Dept. of Public Safety. He trained at their academy for 22 weeks and became a State Trooper in the Highway Patrol. Jim has been stationed in the West or Northwest Harris and Waller Counties since hitting the road with the DPS Highway Patrol.

Jim continued his flying hobby in small planes and helicopters actively until 1995 when he decided he spent too much money on this hobby. He bought some land in NW Harris County and began plans to build a house on it one day. He currently is in the Commercial Vehicle Enforcement service of the Highway Patrol where he is engaged in Federal and State inspections of commercial vehicles. Jim is married to Sharon Monteith, H&T Secretary, and he has a 223year old daughter and almost 11 year old son. Jim and Sharon built their house in the country in 1999. Jim and Sharon have been Society members since 2001. Jim currently serves as the Society's Sub-Chieftain and Editor of the monthly newsletter, 'The Houston Scot'.

H&T Designates Joan McClure Recipient of 2005 Dixon Hedges Award

The officers of The Heather & Thistle Society have selected Joan McClure as their choice for the 2005 Dixon-Hedges award.

This award is presented annually to a non-officer who has generously contributed their time and talent to our Society. It was established in order to recognize those individuals who have served us well. It is always announced and displayed at The Burns Supper.

Joan claims Clan MacLeod by marriage and Ferguson by descent. Both families were early Texas settlers and listed in First Families of Texas. Joan's Ferguson was from Virginia and was a Revolutionary Patriot Soldier. Both families followed the Scottish migration pattern – Virginia and North Carolina, across thru Tennessee into Arkansas and then Texas.

Joan taught school while her husband, Bob was in medical school, and then worked as a secretary to the Chief, Professional Services at the VA Hospital in Houston while Bob was in residency. She "retired" to have a family and also kept active as president of the county medical society auxiliary and later of the state medical auxiliary. She has been a docent at Bayou Bend since 1979 and has served as General Chairman of the docent organization. She has served her DAR chapter as Registrar for four years. She is also a member of DRT and UDC.

Joan and Bob were members of the Scottish Heritage Society and served as board members. That group dissolved sometime around 1990.

Their son is a district attorney in San Antonio. He has a daughter who is a junior at Rhodes College in Memphis and a son who is a sophomore at Saint Mary's Hall in San Antonio. Joan's daughter is a police officer in the Plano department and teaches many training classes. She has a son who has just returned from three years overseas in the Air Force and a daughter who is working.

For the past six years, Joan has taken charge of handling the tickets sales for The Burns Supper. She participates in all the planning meetings to ensure that all flows smoothly

Joan has also hosted many dinners for our "Immortal Memory" speaker. Joan regularly attends our H&T meetings, and is active in The Burns Club.
