Walter May and Becci Himes will be taking over as Co-Chairmen of 2007 Burns Supper planning Committee.

**Past Chieftains:** Walter May advises that he will be working on revising the H&T by-laws. **Programs:** Cheryl May reports that member Mark Monroe is working on more folk music entertainment possibly in September and October. We hope to have RSCDS again in November.

**Sunshine:** Eileen Moore reported on the passing of member Ellen Johnson. Her mother, Janet Johnson, was able to attend tonight's meeting. Janet thanked everyone for their concern. Member Carolyn Sherry who recently was injured was sent a card.

**Houston Highlanders:** Chieftain Jim Monteith reports that he had a nice conversation with H&T member Scott McPhee at the recent Highland Games. Scott is a member of the Houston Highlanders and is willing to keep us informed about their performances.

Sergeant-At-Arms reports 26 members present.

Old Business: None.

New Business: Chieftain Jim Monteith discussed how the Societies Tartan banners appeared to be a big attraction for people attending the recent Highland Games. He suggests that next year we put up as many of our tartans as we can. Motion made by Eileen Moore to change the quorum needed to conduct a business meeting from 20 members to 15 members. Cattle - Historically, cattle were important indicators of wealth especially among the Highland Clans and in the Borders. Cattle 'lifting' or rustling were age-old activities, generating much lawlessness. Later both cattle and cattle trade were vital elements in the development of both agriculture and the export economy during the seventeenth and eighteenth centuries. Pastoral agriculture was always important in the west of Scotland and in the Highlands and islands, but became a major economic activity after the Union in 1707. Early enclosure in the Lowlands was directed at cattle feeding. A significant trade developed during the 18th century from the Highlands to the Lowlands -and further south across the Border to markets in England - invariably over drove roads linking the major 'trysts', or market places, such as that at Falkirk. The later development of steam shipping and ultimately of the railways put an end to the droving trade – but nevertheless pastoral agriculture (both cattle and sheep) remained the mainstay of farming in many parts of Scotland. Sheriff — A key figure in the judicial system since the twelfth century. By the sixteenth century it had become an hereditary appointment with the extensive duties that it involved, including outlawing criminals, settling territorial disputes or enforcing taxation, being undertaken by various deputies. The Crown rarely tampered with the hereditary aspect of the system and when Charles I (1600-49) did deprive the Gordons and certain other families of their hereditary sheriffdoms it was a highly unpopular action. Thus it was not until the aftermath of the Jacobite Rebellion in 1745-46 that heritable jurisdictions were finally abolished in 1747. Thereafter the country was organized into a series of principal sheriffships with sheriff-substitutes designated for every county town. Today the sheriff-substitute remains the judge before whom both civil and criminal cases are initially heard with more serious charges ultimately being referred to the High Court. (from The Collins Dictionary of Scottish History)

Militia Act – While law and order was threatened by radical ideas after the French Revolution, it was not until the Franch Revolution and the Napoleonic Wars that Britain was physically threatened by invasion. During the period 1793-97 the French had achieved a number of successes, while Britain experienced mixed fortunes. There was civil unrest – notably in Ireland – and this was aggravated by naval mutinies among the fleet at Spithead, the Nore, and at Yarmouth. The danger of invasion was ever present and to counter this the government implemented a series of emergency measures, including the Militia Act, the Scottish Militia being formed in 1797. The act enforced conscription by ballot for men between eighteen and twenty-three and provoked serious disorder. This arose from the fact that militiamen could be drafted overseas and that most of the middle and upper classes were either Volunteers (and thus exempt from conscription) or could afford to buy themselves out. Anti-militia disturbances broke out in many places, as 'Scotland went stark mad', according to one contemporary. Schoolmasters, who had to draw up lists of men for the militia ballot had their homes ransacked and parish registers destroyed. The most serious riot occurred at Tranent, East Lothian, where colliers and salters resisted the ballot. The disturbance was ruthlessly suppressed by troops, with eleven person killed and several wounded. Order was restored by the end of the year and further inducements of favourable pay and pensions offered to those who would enlist. The quotas for the Scottish Militia were eventually fixed in March 1798, but it was not until 7 months later that all of the 6,000 men were at last mobilized.
