Heather & Thistle Society – Minutes 24 September 2007

Chieftain Dr. Kenneth Sorrels called the business meeting to order at 7:33 pm in the auditorium of the St. Thomas Episcopal School. The motion was made to accept the June 25, 2007 minutes as published in the newsletter. Motion passed.

Discussion: A correction to the corrections reported from May's meeting was made when it was noted Dr. Arthur Down was not mentioned in the May meeting minutes. One can guess the reported misspelling was from the 2007 updated Membership Directory.

Treasurer Report: Dr. Robert Moore reports the bank balance to be \$3493.04. As of 9/24/07 H & TS has received \$745.00 and spent \$139.69. *"The Burns Supper Committee"* account has \$1411.41 and has received \$1.50 in interest. The motion was made to accept the treasurer's report. The motion passed.

Discussion: It was noted by Jack Hume that the "The Burns Supper" account mentioned by Dr. Moore is in fact "The Past Chieftain's Reserve Account".

Membership Report: Eileen Moore reports 107 family, 45 single, 33 life, 40 exempt, 4 complimentary memberships for a total of 229 members. The total number of non-paid memberships is 45. The deadline for membership payment allowing discounted Burns Supper ticket purchase is Sept. 30, 2007. It was further reported that unpaid members would be dropped from the Membership Directory rolls. The motion to accept the membership report was made and passed.

Discussion: Jack Hume expressed concern for the 45 non renewing members.
